

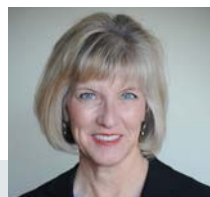
# The Heights

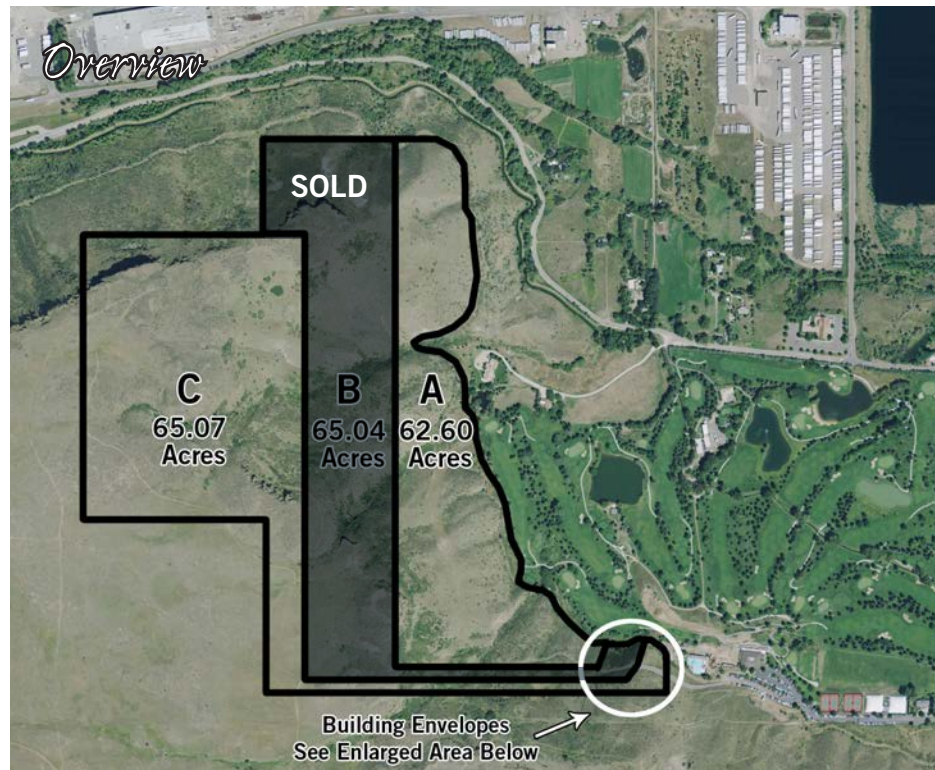
